Choose to meet with any of MetLife's more than 18,500 network attorneys in-person or by phone for a one-on-one consultation in a private and supportive environment. There are no claim forms to file for covered services when using an in-network attorney. You and your spouse can access professional attorneys to help you prepare or update a will, living will, or assign a power of attorney. Choose to meet in-person, virtually, or by phone with a participating in-network attorney. Fees are fully covered for in-network attorneys and there are no claim forms to file.

With MetLife's Will Preparation services, you have access to professional resources to help ensure your final wishes are clear. Here is how to get started:

1. Contact MetLife Legal Plans at [legalplans.com/estateplanning](https://legalplans.com/estateplanning) or by calling 800-821-6400 and a Client Service Representative will:
  - o Ask for your Company name (NYSNA Benefits Fund), Group Number (224689), and the last 4 digits of your Social Security number
  - o Locate a participating plan attorney in your area
  - o Provide you with a case number to give to the attorney of your choice
  - o Answer any questions you may have
2. Next, call the office of your chosen attorney to make an appointment at a time that works best for you.
3. Talk to an attorney as many times as needed to prepare, update or revise a will.

*Individuals have the option to use the out-of-network reimbursement feature to retain an attorney who does not participate in MetLife Legal Plans' attorney network. If an out-of-network attorney is chosen, the individual will be responsible for any attorneys' fees that exceed the reimbursed amount. Will Preparation is offered by MetLife Legal Plans, Inc., Cleveland, Ohio. In certain states, legal services benefits are provided through insurance coverage underwritten by Metropolitan General Insurance Company, Warwick, Rhode Island. For New York State situated or principally located cases, the Will Preparation service is an expanded offering that includes office consultations and telephone advice for certain other legal matters beyond Will Preparation. Tax Planning and preparation of Living Trusts are not covered by the Will Preparation Service.
